The purposes for collecting the information is to provide, education, training, welfare and educational support services. The Kingsbridge Educational Trust (KET) collects and uses certain types of personal information about pupils, parents and other individuals who come into contact with the Trust in order provide education and associated functions. The Trust is committed to complying with the data protection principles as laid down in the GDPR at all times. This means that personal data processed for any purpose(s) shall not be kept for longer than is necessary for that purpose/those purposes and the Trust will regularly review the records held to ensure that information is not held longer than is necessary, and that it has been held in accordance with the data retention policy. The Trust's Data Protection and FOI Policy ensures the rights for access to information, rectification, erasure, to restrict or object to processing and data portability are in accordance with the GDPR. The Trusts' Data Protection and FOI Policy ensures the right to withdraw consent at any time, though that withdrawal does not render any processing carried out before the withdrawal unlawful. Data subjects have the right to complain to the Information Commissioner's Office (the "ICO").
